This warranty shall be read and construed subject to any such statutory provisions. This warranty gives the Owner specific legal rights.

SHOWOOD offers a ten (10) year limited warranty for all of its WPC Products. This warranty applies to any SHOWOOD Product that has been properly installed under the conditions of the SHOWOOD Installation Guide and yet shows signs of defect, such as splintering, flaking or corroding. This warranty further covers any SHOWOOD Product which, although properly installed, becomes structurally unfit from rotting, splitting, cupping, termite or fungal decay within ten (10) years from the date of purchase. Colour variations and slight fading may occur, however the warranty ensures the material will never lose its inherent colour properties. The SHOWOOD Limited Warranty does not cover the cost of installation, removal of debris/waste or re installation and transportation of materials. The manufacturer's sole obligation is limited to the replacement of SHOWOOD Products only and shall have no further obligation or liability except as stated herein. SHOWOOD may elect to pay a percentage of the original purchase price under the prorated schedule within the warranty in lieu of replacement of the SHOWOOD Product/s. The Owner assumes all risk and liability associated with the construction and use of SHOWOOD Products. The Owner acknowledges that SHOWOOD Products are not structural lumber and therefore may not be used as such. SHOWOOD recommends taking all necessary steps to ensure the safety of everyone involved in the use and construction of SHOWOOD Products, including but not limited to, wearing/using the proper safety equipment and working in appropriate weather

If you are not satisfied with the terms and conditions provided in this Limited Warranty, please return all unopened marketable SHOWOOD Products to the original place of purchase for a refund.

SHOWOOD does not warrant against and is not responsible for any condition attributable to:

- (1) improper installation of SHOWOOD products and/or failure to abide by SHOWOOD installation guidelines, including but not limited to improper gapping;
- (2) use of SHOWOOD products beyond normal residential use, or in an application not recommended by SHOWOOD guidelines and local building codes;
- (3) movement, distortion, collapse or settling of the ground or the supporting structure on which SHOWOOD products are installed;
- (4) any act (such as flooding, hurricane, earthquake, lightning, etc.), environmental condition (such as air pollution, mold, mildew, etc.), or staining from foreign substance (such as dirt, grease, oil, etc.);
