

10-YEAR WARRANTY RESISTANCE TO THE ATMOSPHERIC EVENTS AND HAIL

A) WARRANTY DECLARATION

The warranty covers all PolyPIU' products in U.V. protected multiwall polycarbonate with the following characteristics:

- 1) After 10 years, the product's light transmission value will be no more than 4 percentage points below the initial value measured according to ASTM D-1003-77 standard.
- 2) The degree of yellowing is determined according to ASTM 1925-77 test method and must have an index of 6 delta units below the initial value.
- 3) The following conditions apply to the warranty clause related to hail:
 - the sheets must be minimum 6 mm thick.
 - the sheets do not break based on the results of a hail impact simulation test using 20 mm diameter artificial balls at an impact speed of 21 m/s.

B) WARRANTY EXCLUSIONS

The warranty does not apply in the event of damage caused by accidental impacts and vandalism and excludes: transport, removal and new installation or other uses. The warranty is not valid if the defect can be attributed to violent knocks during transport and/or handling, or "incorrect" storage, machining, installation and conservation; "incorrect" situations are when the instructions contained in PolyPIU' documentation and technical manuals are not followed and particularly with regards to the radii of cold-curving carried out on site.

C) WARRANTY LIMITS

This warranty was issued on 1st January 2017 and replaces any other written and spoken warranty, express or implicit, including warranties of merchantability.

D) WARRANTY VALIDITY CONDITIONS

UV protected PolyPIU' products:

- 1) Must be free of scratches and/or abrasions,
- 2) Must not be damaged by connection, fixing and/or insulating elements,
- 3) Must not be exposed to the action of chemical products or corrosive material,
- 4) Must be installed with the UV protected side facing outwards, exposed to the weather,
- 5) Must be supplied and installed in Europe,
- 6) Are also guaranteed for thicknesses below 6 mm in the event that they are in corrugated or greca profile manufactured by PolyPIU'.

NOTE: This warranty is only valid if it is complete with the product data, name and address of the purchaser and the invoice must be carried out within the warranty period. On request from PolyPIU', the claimant must allow the material to be inspected on site and/or the claimed product must be returned to PolyPIU' for assessment. PolyPIU' reserves the right to assess the cause of the defect independently.

E) PLACE OF JURISDICTION

This warranty is governed by national laws – the place of jurisdiction for any controversy will be the Milan law court.

F) WARRANTY ENFORCEABILITY

- 1) Every warranty application request must be sent to PolyPIU' immediately after the defect occurs, along with a copy of the warranty and of the invoice.
- 2) The damage claimed and the presumed causes must be described and documented in order to proceed with concession of the warranty.

In the event of justified claims, PolyPIU' will replace the material free of charge in accordance with the following table, without recognition of blame:

In the event that replacement within a reasonable period of time is not possible, PolyPIU' reserves the right to reimburse the product's original price, based on the table above, without recognition of blame.
